PMY is committed to conducting its business in a moral and ethical way. It understands and recognises the need for corporate governance policies and business practices which not only reflect PMY's core values but also comply with relevant legal and regulatory frameworks. In support of this commitment, PMY continuously improves its approach to addressing modern slavery risks, including implementing, and enforcing effective systems and controls.

# **SCOPE**

This statement is prepared and issued by reporting entity PMY Group Pty Ltd and covers all controlled entities across the group for the purpose of reporting requirements for Australia's Modern Slavery Act 2018 (Cth) and section 54 of the Modern Slavery Act 2015 (UK) for the financial year ended 30 June 2025.

## **OUR BUSINESS**

PMY is headquartered in Melbourne, Australia and employs approximately 500 staff located across three regional hubs, APAC, EMEA, and the USA. PMY is a full-service technology solutions provider, specialising in enhancing the way people operate and experience public venues, places, and major events. From its origins in stadium technology, PMY has broadened its scope, now servicing over 1,000 clients in 15 countries, across a diverse array of sectors.

# **OUR SUPPLY CHAIN**

Our business model includes the delivery of services and solutions across strategy, design, implementation, operations and data relating to venue technology. Our clients procure hardware and software technologies across the following primary areas:

- Digital signage; (LED, LCD and displays)
- IPTV;
- Network:
- Production:
- · Software licenses; and
- Supporting implementation services such as electrical, engineering, and maintenance contractors.

PMY also utilises third party services to support our day-to-day operational needs such as external legal, marketing, cleaning, IT, and financial services.

# **RISKS OF MODERN SLAVERY**

The supply chain supporting PMY are diverse in both category and location. However, the risk of modern slavery activity in our direct business and supply chain has been assessed as low. PMY has close working relationships with our major suppliers and has high expectations for them to have robust processes, to match our own and ensure compliance with the relevant legislation.

### **OUR PROCESSES**

PMY's commitment to identifying and eradicating modern slavery in its operations and supply chain is reflected in several policies and processes implemented by the group during the reporting period as outlined below.

#### a. Modern Slavery Policy

PMY implemented a modern slavery policy in 2023 whereby every employee and contractor of PMY must take reasonable steps to ensure the business is not engaging in modern slavery practices. The policy has raised awareness of the existence of modern slavery in business practices and how to report and act on any observations of potential modern slavery operations. All new and existing employees are required to acknowledge and agree to abide by this policy.

#### b. Procurement Policy

PMY have a controlled procurement process which includes undertaking supplier due diligence including a vendor risk assessment where suppliers are assessed against an internal criterion. A supplier prequalification form is required to be completed for all our major procurements. This includes checking the supplier's modern slavery policy and statement where applicable. As part of this process, we have identified a shortlist of suppliers who we will not engage with as they do not meet our strict internal compliance and quality guidelines. This procurement process has been externally audited and successfully ISO certified in 2024 and 2025 by Citation Group for the applicable Australian entities. Throughout the last 12 months PMY have extended this procurement process and vendor due diligence across the EMEA region.

#### c. Global Code of Conduct

PMY has implemented a global code of conduct which outlines how our workforce approaches social issues including human rights. At PMY, we aim to only work with business partners and suppliers who embrace standards of behavior consistent with those of PMY. PMY has a zero-tolerance policy against all forms of human trafficking and modern slavery related activities.

#### d. Training and Awareness

Employees are educated about the Australian and UK Modern Slavery Acts and made aware of the important role they play in identifying signs of breaches with the Acts within our operations and supply chain. Employees are actively encouraged to report concerns via our workforce participation and feedback platform and our whistleblower policy.

# **EFFECTIVENESS OF OUR ACTIONS**

PMY's Australian operations have an Integrated Management System (**IMS**), which integrates various management systems, policies, objectives, and processes, ensuring that we meet our goals effectively.

The IMS is independently audited on an annual basis, with any identified risk areas flagged for action and continuous improvement. The IMS acts as an efficient mechanism to monitor the effectiveness of our processes to reduce any risks in our supply chain, including modern slavery.

As part of PMY's corporate governance process and objective for continuous improvement, our policies are continually updated and reviewed to ensure they remain relevant as we diversify and scale our operations. These internal governance reviews and processes ensure that modern slavery risks are considered throughout procurement, HR and overall operations.
